

To the Plans and Specifications for the Stafford MSD RFP #20 - 002, this addendum forms a part of the Contract Documents and modifies said documents as follows:

### PART 1 - GENERAL

**Item 1.** Pre-Proposal Meeting was held last Tuesday. See attached for Sign-in sheet and LAN's agenda discussed during the meeting.

### **RFI QUESTIONS AND ANSWER**

Q1: Is the play structure in-ground or surface mounted on to concrete?

A1: For the playground equipment (excluding the basketball goal post equipment) that is located on concrete for both sites, the play equipment may be surface mounted or in-ground for locations of new concrete and for the existing concrete, it may be at the manufacturer's discretion and recommendation, i.e. if needed, it may require saw-cutting of the existing concrete depending upon the manufacturer recommendation.

The padding and artificial turf, cover the surface mounted plates and connections – to be very clear, no surface mounted items have the surface mounted plates exposed except the music components that are to be provided on the existing concrete for the Elementary site, are exposed surface mounted. For the Pre-k swings that are located on compacted base, this is an in-ground installation. The basketball goal footings are detailed for both sites and included within the document drawings
